# Terms and Conditions of the Contest for the mascot of the European Games 2023 organized by the European Games 2023 Ltd.

## § 1 General Provisions

- 1. The organizer of the "Contest for the European Games 2023 mascot", hereinafter referred to as the "Contest", is the company Igrzyska Europejskie 2023 sp. z o.o., based in Kraków, hereinafter referred to as the "Organizer".
- 2. The founder of the prizes is the company Igrzyska Europejskie 2023 sp. z o.o., based in Krakow, Poland.
- 3. The contest is organized in connection with the European Games 2023, which will be held June 21-July 2, 2023.
- 4. The Regulations constitute the basis for the organization of the Contest and define the rights and obligations of its participants.
- 5. The Contest has a nationwide character.

## § 2 Conditions of participation in the Contest

- 1. The subject of the Contest is to design a mascot promoting the European Games 2023, hereinafter referred to as the "Mascot".
- 2. The Competition is addressed to: children and high school students from 5 to 15 years of age, hereinafter referred to as "Participants".
- 3. Persons related to employees of the Contest Organizer are excluded from participation in the Contest.
- 4. Participation in the Contest is free of charge and completely voluntary. This means that the authors are not entitled to any remuneration or reimbursement of costs incurred for the preparation of projects.
- 5. Contest works must be author's works, not submitted and not previously awarded in other competitions, unencumbered by legal defects or claims of third parties.
- The Entrant and his/her legal guardians, together with the entry of the Entrant to the Contest, declare that they have familiarized themselves with the Contest rules provided to them in these Regulations and that they accept them.
- 7. The Entrant and his/her legal guardians, together with the entry of the Entrant to the Contest, declare that they have familiarized themselves with the Contest rules provided to them in these Regulations and that they accept them.
- 8. The Contest may only be participated in person, with the consent of the legal guardian, by submitting a work made by the Participant. It is unacceptable to make contest entries on behalf of third parties.

### § 3 Rules of the Contest

- 1. The Contest shall begin on September 5, 2022 at 12:00 a.m. and shall end on September 30, 2022 at 12:00 p.m.
- 2. The results of the Contest will be announced by October 14, 2022 in the news on www.ie2023.pl.
- 3. Information about the Contest will be published in the news on www.ie2023.pl
- 4. The condition for participation in the Contest is to make a Contest work consisting in the preparation of a design / drawing of a Mascot (hereinafter also referred to as the "Contest Work") and send it together with the following documents to the address of the Organizer's registered office (ul. Kamienna 21, 31-403 Kraków) or to the e-mail address: konkurs@ie2023.pl by September 30, 2022 at 12:00 a.m., together with the following documents:
  - a) completed and signed by the Participant's parent/legal guardian the Contest Entry Card, constituting Attachment No. 1 to the Regulations. The card shall include a statement of the Contest Participant's parent/legal guardian that he/she is aware of and accepts the provisions of the Regulations, consent, of the Contest Participant's parent/legal guardian to participate in the Contest, consent to the processing of personal data,
  - b) completed and signed by the Contest Participant's parent/legal guardian consent to the transfer of author's economic rights to the European Games 2023 sp. z o.o., based in Krakow, according to the template set forth in Attachment No. 2 to the Regulations. The transfer of author's economic rights applies to the winning works.
- 5. Large graphic files should be uploaded using any free hosting platform designed for uploading large files.
- 6. The Contest Organizer will not consider damaged files.
- 7. The Contest works submitted after the deadline specified in § 3 paragraph 1 of the Regulations will not participate in the Contest.
- 8. One person may submit one Competition work prepared by him/her.
- 9. It is forbidden for the Entrants to include in the Contest Works, content that violates good morals, applicable law or any rights of third parties. In particular, it is forbidden to include pornographic, vulgar, offensive, violating personal rights, promoting violence, alcohol consumption, smoking, use of stimulants or discriminatory content. The Organizer has the right to exclude

- an Entrant from the Contest, and Contest Works containing such content will not participate in the Contest.
- 10. Entries of Contest Works that violate other terms of these Regulations will be excluded from the Contest.

# § 4 Principles of selecting the winning Competition Work

- 1. The Selection Committee (hereinafter referred to as the "Committee"), appointed by the Organizer, shall supervise the proper and proper conduct of the Contest, selecting the winner and awarding the prizes.
- 2. The winner of the Contest will be selected only from among the Participants who meet all the conditions specified in the Regulations.
- 3. The selection of the winning entry will proceed as follows:
  - a) STAGE I: selection by the Commission from among all the Contest Works the three best;
  - b) STAGE II: the three works selected in Stage I will be made available on the official Facebook of the Organizer (European Games Krakow-Malopolska 2023) and voted on by the community. The votes obtained in this way will constitute 20% of the final evaluation, the remaining points will be awarded by the Commission (80%).
- 4. The contest is not created, administered, endorsed or sponsored by Facebook.com or Facebook Inc.
- 5. The Organizer reserves the right to terminate the Contest without selecting the winning entry.
- 6. ewThe Organizer will notify the winner of the method of collecting the prize by e-mail to the parent/legal guardian indicated in the Contest Entry Form (Appendix No. 1 to the Rules). In case of lack of contact from the winner's parent/legal guardian for more than 14 working days from the date of sending the e-mail about how to claim the prize, this will result in forfeiture of the prize to the Organizer.

### § 5 Prizes

- 1. The winner will receive a prize consisting of:
  - a. entry to the EG2023 Opening Ceremony and Closing Ceremony along with a mascot,
  - b. VIP tickets to the ceremony for the family (maximum 4 people),
  - c. a package of official EG2023 gadgets,
  - d. a personalized mascot that will be inspired by the project.

- 1. Regardless of the main prize described in § 5.1, the first one hundred (100) Participants whose Contest Works complying with the guidelines contained in the regulations are sent to the address indicated in § 3.4 will receive a set of gadgets related to the event.
- 2. The order of the submitted Contest Works shall be determined by the date of receipt of the parcel containing the Contest Work at the Organizer's office.
- 3. The prizes referred to in Paragraph 1 and Paragraph 2 above shall be issued under the condition of providing true personal data, i.e.: first name, surname, address of residence and the address to which the prize will be sent, if different from the address of residence. The Organizer stipulates that the prizes may be sent only within the territory of Poland.
- 4. The contest prizes will be issued only in the form specified in the Regulations, without the possibility of payment of their equivalent in cash and without the possibility of transferring the prize to another person. In matters not regulated by the Regulations, the provisions of the Civil Code shall apply.

## § 6 Copyright

- 1. The Participant of the Contest is entitled to full personal copyrights and unlimited author's economic rights to the Contest Work and the texts, slogans, word phrases or signs contained therein, submitted in the Contest (hereinafter also referred to as the "Work").
- 2. At the moment of submission of the Contest Work, the parent/legal guardian of the Contest Participant grants to the Organizer, without remuneration, without time and territorial limitations, a non-exclusive license to use the Work/Contest Work in all fields of exploitation known as of the date of granting the license, in particular those indicated in paragraph 4. The Organizer is entitled to decide on the exercise of dependent copyrights in relation to the Work.
- 3. Upon selection of the winner of the Contest, the parent/legal guardian of the Contest Participant transfers to the Organizer, without remuneration, the author's economic rights to the Work/Contest Work, together with the right to exercise dependent rights, in all fields of exploitation known as of the date of transfer of rights, in particular those indicated in paragraph 4.
- 4. Fields of exploitation:
  - a) in terms of use;
  - b) consolidation of the Work, in whole or in part, by any known techniques and on any media;
  - c) copying, multiplication of the Work, in whole or in part, on carriers in the techniques referred to in paragraph b);

- d) introduction and processing of the Work, in whole or in part, into computer memory and multimedia networks (in particular, the Internet) and data collection in digital form of the content of the Work;
- e) within the scope of circulation of the original or copies on which the Work has been fixed introduction into circulation, lending or rental of the original or copies;
- f) use of the Work, in whole or in part, for reproduction, projection, publication or distribution in mass media, computer networks and at various meetings, conferences and other events connected with the promotion of events organized by the Organizer;
- g) use of the Work in whole or in part for marketing or promotional purposes, including advertising, sponsorship;
- h) making the media available to the public;
- i) translation, adaptation, rearrangement or any other changes in the Work,
- j) Distributing the Work through public performance, exhibition, display, reproduction, as well as broadcasting and re-broadcasting, as well as making the Work available to the public in such a way that everyone may have access to it at a place and time of their own choosing,
- k) introduction of the Work in whole or in part to a computer network in such a way that it may be received by an interested user (Internet), distribution of the Work In the on-line system,
- I) making changes to the Work, its development.
- 5. Use, disposal, modification or distribution of the Work in the fields of exploitation indicated above may take place in whole, in part, in fragments, independently, in combination with other works or works.
- Upon issuance or shipment of the prize, the parent/legal guardian of the Contest Participant transfers to the Organizer, without compensation, the ownership of all media on which the Works were recorded and transferred to the Organizer.
- 7. The transfer of author's economic rights mentioned in this paragraph to the Organizer shall take place without limitation as to time, quantity and territory (it applies to the territory of the Republic of Poland, as well as the area outside its borders). Transfer of author's economic rights to the Work is not limited in terms of the purpose of distribution of the Work. The Organizer may exercise the author's economic rights independently or may authorize third parties to do so or transfer these rights to them.
- 8. The Organizer is not obliged to publish the content of the Work (Competition Works), and the refusal of dissemination does not require justification.
- 9. The Participant's parent/legal guardian undertakes that he/she will not exercise rights under moral copyrights against the Organizer and its

successors. The marking of the work with the name (pseudonym) of their creators is at the discretion of the Organizer, to which the parent/legal guardian of the Participant agreeş free of charge.

## § 7 Information on data processing

- 3. The data will be processed for the purpose of selecting and announcing the winners of the Contest and for the purpose of transferring the prizes to the winners, on the basis of Article 6(1)(b) RODO and Article 6(1)(c) RODO, for the purpose of fulfilling tax and archiving obligations incumbent on the administrator.
- 4. The personal data of the Contest Participants will be stored by the Organizer until the Contest winner is selected, while the personal data of the winner will be stored at least until the Contest winner confirms receipt of the prize, and after that time (if necessary) for the period prescribed by law,
- 5. The data subject shall have the right to access, rectify, delete or restrict processing of his/her personal data.
- 6. The data subject has the right to lodge a complaint to the supervisory authority, which is the President of the Office for Personal Data Protection.
- 7. Personal data provided in the Contest will not be subjected to automated decision-making processes, including profiling.
- 8. Providing personal data is voluntary, however, necessary to participate in the Contest.
